- 2. Pursuant to the above permissions, we commenced the development of the said land on 10<sup>th</sup> of August, 2011 and Bhoomi Poojan was performed on 15<sup>th</sup> Oct, 2011. The bookings of the flats also started from the same day. By this time the construction had commenced in its full swing.
- By the time, we had completed the Basement work and had reached to the level of Plinth completion and as per practice of the MBMC; we had applied for Plinth Completion Certificate.

- 4. The MBMC has thereafter scrutinized and also issued us with Plinth Certificate vide its Order dated 06<sup>th</sup> January, 2015 bearing no. MNP/NR/2860/2-14-15 and we had then reached the construction of the first floor.
- Subsequently, on our application to M8MC, the ADTP of MBMC had applied for Class of land certificate to the Circle Officer of Village Bhayander.
- The Circle Officer, Bhayander has issued a "Class 1" land certificate to the said land and informed to MBMC vide its order dated 17th Dec 2014.
- 7. However to our utter surprise, vide letter dated 28th April, 2015, bearing no. MNP/NR/376/2015-16 from MBMC, marked as Exhibit "1", we were informed that the Class 1 certificate granted by the Circle Officer, Bhayander stand cancelled since they have not been authorized to determine the Occupancy, Class of land and the encumbrance over it etc and we are supposed to submit within 15 days the confirmation from the Office of the Hon'ble Collector Thane regarding the Occupancy, Class of the land and the encumbrance over it or authority letter (Sanad) falling which the permission granted for construction by you to us will be cancelled.
- B. Thereafter as per the procedure prescribed in the MRTP Act, we had applied to the Commissioner, MBMC vide our application dated 11/05/2015 for grant of Sanction of Class 1 land Certificate and The MBMC Commissioner has in turn has applied to the Office of Collector, Thane for ascertaining and seeking a certificate as to which class of occupancy tenure is a particular property held in so as to enable the Planning Authority viz. MBMC to grant development permissions for such property in respect of our said land.
- 9. However, the said application for grant of Class 1 Certificate remained pending at the Collector Thane office. On enquiring with the office of the Collector Thane, we were informed that The Collector Thane has not been issuing the requisite occupancy class certificate, as applied for by the Commissioner, Mira Bhayander Municipal Corporation on the basis of a presumption (albeit erroneous) that by virtue of the ad-interim order dated 6th August, 2015 (marked as Exhibit '2') of the Bombay High Court in Writ petition No. 6751 of 2015 filed by the Estate Investment Co

Pvt Ltd(EICPL) against the Government of Maharashtra the Collector Thane is not permitted to or is restrained from issuing issue such a certificate.

- 10. We had then represented to the Hon'ble Collector Thene and have stated that EICPL has no right, title and interest into or upon the said land and/or any part thereof; and that all the rights, title and interest of the EICPL, in respect of the said land were released and transferred in our favour by virtue of a registered Release Deed dated 7th January, 2011 executed by the EICPL in our favour and the said order is not applicable to us.
- 11. However, since the name of the EKPL appears on the revenue records (7/12 extracts) in respect of the said land, the Collector Thane refused to act on the application of the MBMC for issuing the Class I Certificate in respect of the said land and also on the basis of the letters dated 11<sup>th</sup> December, 2015 and 20<sup>th</sup> April, 2016, the officers working with the office of the Hon'ble Collector Thane orally informed us that till the Applicant does not obtain a clarification from the Hon'ble Court that the said ad-interim order dated 6<sup>th</sup> August, 2015, passed in the said writ petition No. 6751 of 2015 does not restrict the Collector Thane from Issuing the Class I Certificate in respect of the said land, the application of the MBMC for issuance of the Class I Certificate in respect of the said land, will not be considered or processed further by the office of the Collector Thane.
- 12. In the circumstances, being aggrieved by the inaction of the Collector Thane in Issuing the Class I Certificate, we had filled Civil Application Stamp No. 33431/2016 seeking a clarification from the Hon'ble Court that in the fact and circumstances of the present case, the ad-interim order dated 6th August, 2015 passed in the Writ Petition does not affect the said land and cannot restrict the Collector-Thane from Issuing a Class I Certificate to the Applicant in as much at the EICPL Itself has no right, title and interest into or upon the said land by virtue of the Release Deed dated 7th January, 2011 executed by the EICPL in favour of us.
- By its Order dated 27th June, 2017 ("said Order") (marked as Exhibit '3') (passed by the Hon'ble High Court of Judicature Act at Bombey in Civil Application (St) no.33431 of 2016 in Writ Petition no.6751 of 2015 ("said Civil Application"), the Hon'ble Court was pleased to dispose off the said

Civil Application filed by our client, in terms of prayer clause (b) of the Civil Application, which reads as follows:

"This Hon'ble Court be pleased to clarify that that the said ad-interim orders dated 16° hely 2016 and 6° August, 2015 (Edubit B' bereto) does not pertain to the said Property of the Applicant no. 1 i.e. part of land bearing Old Survey no. 476, New Survey no. 120, Hisso no. 2, admeasuring 8590 square meters situate, lying and being at Village Bhayandar, Taluka and District Thane, in the Registration District and Sub-District Thane and now within the limits of the Mira Bhayandar Municipal Corporation; and that this Hon'ble Court be pleased to direct the Respondent no.2 to process further the application dated 11° May, 2015 filed by the Mira Bhayandar Municipal Corporation with the Respondent no. 2 for issuance of the Class I Certificate in respect of the said Property, natwithstanding the ad-interim orders dated 16° July, 2015 and 6° August, 2015, in the Writ Petition no. 6251 of 2015".

- 14. Thus, as per the said Order, The Collector- Thane have been directed by the Hon'ble Court to process further the Application dated 13° May, 2015 filed by the Mira Bhayander Municipal Corporation for issuance of Class I Certificate in respect of Property, owned and being developed by us i.e. part of land bearing Old Survey no. 476, New Survey no. 120, Hissa no. 2, admeasuring 8580 square meters situate, lying and being at Village Bhayandar, Taluka and District Thane, in the Registration District and Sub-District Thane and now within the limits of the Mira Bhayandar Municipal Corporation, notwithstanding the ad-interim relief passed in the above referred Writ Petition.
- 25. Consequently we informed to The Hon'ble Collector Thane vide our advocates letter dated 14th July 2017 and asked them to kindly comply with the Order dated 27th June, 2017 passed by the Hon'ble Court at the earliest by processing further the above referred Application dated 11th May, 2015 filed by Mira Bhayander Municipal Corporation for Issuance of Class I Certificate in respect of the above referred property to us.
- 16. The Hon'ble Collector Thene has thereafter issued the "Sanad" dated 6<sup>th</sup> April 2018 in respect of the said land and the copy of the same is attached herewith marked as Exhibit '4'.
- Hence in view of the above, you are not requested to kindly revalidate our building plan approvals and permissions and revalidate our Commencement Certificate on a urgent basis.

18. Please note that the project on the said land is registered under MahaRERA and the MahaRERA Registration Number is P51700002231 and a copy of the MahaRERA Registration Certificate is

attached herewith and marked as "Exhibit '5'.

19. Also we have sold various flats and shops in the said project to various customers for whom we are answerable and due to the substantial delay of the approvals for no fault of ours; we are not

able to do the construction work. So we earnestly request you to kindly grant us the requisite

approvals immediately without any further delay.


