However the construction work should be commenced within three months from the date of its issue. This permission does not entitle you to develop land which does not vest In you or in contravention of provision of coastal Zone Management Plan. If construction is not commenced this Commencement Certified is renewable every year but such extensering shall be in no case exceed three years provided further that such lapse shall not bar any subsequapplication for fresh permission under section 44 of the Maharashtra Regional and Town Planning Act. 1966. This Certificate is liable to be revoked by the C.E.O. (SRA) if:- (a) The development work in respect of which permission is granted under this certificate is not care out or the use thereof is not in accordance with the sanctioned plans. (b) Any of the condition subject to which the same is granted or any of the restrictions imposed the C.E.O. (SRA) is contravened or not complied with. (C) The C.E.O. (SRA) is satisfied that the same is obtained by the applicant through fraud misrepresentation and the applicant and every person deriving title through or under him in an event shall be deemed to have carried out the development work in contravention of sec 43 and 45 of the Maharashtra Regional and Town Planning Act 1966.
