- 2. I have perused the above said documents, which reveals that, Land bearing CTS No. 1681, Gut No. 85/P, Plot No. 10, admeasuring about 478.5 Sq. Mtrs., was originally owned by one Shree Adarsh Nivas Kendra through its Promoter's Shri. Vinayak Rajaram Teredesai 2) Jagannath R. Teredesai, 3) Mangala Dattatray Ghatpandey, 4) Sarasvati Govind Vaidya and 5) Shri. Vinayak Mahadev Joshi and the same was purchased by Shri. Kashinath Mahadev Thanekar, resident of Thane on 12/10/1960 vide Registered Sale Deed duly registered with Sub Registrar of Assurances, Thane at Serial No. 522 dated 12/10/1960. There after the revenue department after perusing the necessary documents and making enquiry has transferred the entries in the name of Shri. Kashinath Mahadev Thanekar vide pherphar No. 150, dated 19/06/1961. Herein after referred to as the "Said plot of land".



- 3. I have also noticed that, Shri. Kashinath Mahadev Thanekar obtained construction, permission, vide commencement Certificate No. 262, dated 26/11/1968 from Thane Borough Municipality to construct the building on the said plot of land, consisting ground plus two upper floors having totally 9 flats, i.e. 3 flats on ground floor, 3 flats on first floor, 3 flats on second floor, and after the completion of the construction of the said building, he obtained occupation Certificate No. 1923/4047, dated 31/03/1970 from Thane Borough Municipality. - 5. I have also noticed that, Shri. Kashinath Mahadev Thanekar expired intenstate on 04/09/1999 leaving behind him his legal heirs i.e.1) Smt. Laxmi Kashinath Thanekar, 2) Shri. Hemkant Kashinath Thanekar, 3) Shri. Dinanath Kashinath Thanekar 4) Sanjeevani Suresh Thanekar 5) Kumudini Ramakant Patil 6) Draupadi /Usha Nishikant Mandvikar 7) Janhvi Jayant Nakhawa. The legal heirs of Late Shri. Kashinath Mahadev Thanekar applied to the Revenue Authorities for inserting their names in the Revenue records instead of Late Shri. Kashinath Mahadev Thanekar. Thereafter the Revenue Department, after perusing the necessary documents and making inquiry has transferred / inserted the names of above said legal heirs in the Revenue records vide Pherphar no. 376, dated 05/12/2000.

- I have also noticed that, 1) Sanjeevani Suresh Thanekar 2) Kumudini 6. Ramakant Patil 3) Draupadi @Usha Nishikant Mandvikar 4) Janhvi Jayant Nakhawa the daughter of Late Shri. Kashinath Mahadev Thanekar, released their right, interest in the said Plot of Land and the said Building i.e. "Aparna Shailesh Building" vide Registered Release Deed dated 07/12/2000, duly registered with the Registrar of Assurances Thane at their document no TNN-1-7035/1-12/2000, in the favour of the other owners i.e. 1) Smt. Laxmi Kashinath Thanekar, 2) Shri. Hemkant Kashinath Thanekar, and 3) Shri. Dinanath Kashinath Thanekar an application to the Revenue Department after perusing the necessary documents and making inquiry the Revenue Department has deleted the names of the releasing legal heirs i.e. 1) Sanjeevani Suresh Thanekar 2) Kumudini Ramakant Patil 3) Draupadi @Usha Nishikant Mandvikar 4) Janhvi Jayant Nakhawa and kept the names of Smt. Laxmi Kashinath Thanekar, Shri. Hemkant Kashinath Thanekar, and Shri. Dinanath Kashinath Thanekar, as the owners of the said plot of land vide pherpar no. 378 dt. 01/01/2001. I have also noticed that, on 10/04/2006 the same effect was given in the property card in respect of CTS No. 1681.
 - 7. I have also taken search of the said property for last 60 years and have not noticed any transaction till today. I have also given public notice, inviting objections, in one month, from the publication of notice, of any interested person in the said property. The said notice was published in daily news papers 1) "NavShakti, 2) The Free Press Journal, 3) Thane Vaibhav, 4) Dainik Kokan Sakal on 13th December, 2018, however till today, I have not received any objections of whatsoever nature in respect of the said property from any person from the public.
 - After going through the above said documents and upon the information given by Smt. Laxmi Kashinath Thanekar, Shri. Hemkant Kashinath Thanekar, and Shri. Dinanath Kashinath Thanekar, said property i.e. land admeasuring about 478.5 Sq. Mtrs., and Building
